#### WHAT IS THE SAC?

#### The School Accountability Committee is a MSCS Board Committee that is required by state statute to fulfill following responsibilities:

- Making recommendations on the school priorities for spending school moneys, including federal funds, (MSCS Finance Committee is responsible for this); or concerning preparation of a school Performance or Improvement plan;
- Publicizing & holding a SAC meeting to discuss strategies to include in a school Priority Improvement or Turnaround plan
- Publicizing the district's public hearing to review a written school Priority Improvement or Turnaround plan;
- Meeting at least quarterly to discuss whether school leadership, personnel, & infrastructure are advancing or impeding implementation of the school's Performance, Improvement, Priority Improvement, or Turnaround plan, whichever is applicable, & other progress pertinent to the school's accreditation contract;
- Providing input & recommendations on an advisory basis, concerning principal development plans & evaluations;
- Assisting the district in implementing at the school level the district's family engagement policy
- Publicizing opportunities to serve and soliciting parents to serve on the SAC
- Assisting school personnel to increase family engagement with teachers, including family engagement in creating READ plans, Individual Career & Academic Plans, & plans to address habitual truancy

## SAC Composition

- · Principal or Principal's designee
- · At least one teacher
- At least three parents of students enrolled
  At least one adult member of Parent Council
- At least one community members

#### Parent representatives must:

- Reflect student population
  Not be employed by the school
- · Have a chair of co-chair that is a parent

# MSCS SAC Responsibilities:

- Helps identify strategies for school improvement/parent engagement/ attendance. These strategies are included in the school's Unified Improvement Plan
- Oversees the annual Parent Engagement Survey

# SAC Yearly Calendar

August - October:

· Recruit new members, especially members that are representative of student population

· Establish areas of focus & schedule for the year

Implement onboarding plan for new members

Elect the chair (and officers, if applicable)
Review the SPF and DPF, results of state and local assessments, and nonassessment data (e.g., survey, engagement data)

· Review UIP before October 15 submittal (skipping this year for biennial flexibility)

Review parent engagement policies

November-January:

Review progress implementing the UIP and discuss any mid-course adjustments
Continue to support implementation of the parent engagement policy
If applicable, assist the school in increasing engagement in creating students' READ

· If applicable, review truancy data and provide feedback on plans to address habitual

truancy

• Review current year budget and discuss implications for the upcoming school year (Finance Committee)

#### ABOUT MOUNTAIN SONG

- Started in 2013
- Only Waldorf-based school in the Pikes Peak Region
- Public charter school authorized by Charter School Institute
- Recently changed from Three-fold governance model to Executive Director model



## ABOUT MOUNTAIN SONG Continued

- Charter renewed by CSI last year
   received 3 years plus 2 contract
  Still maintains "Performance Rating" by state
- · Programs offered:
  - Village (in-person) Homeschool Enrichment Frontier (online) Homeschool Enrichment

  - Justice and Heritage AcademyFull-time educational services

### ABOUT MOUNTAIN SONG STUDENTS

- ~400 students in total enrolled
  - 63% White/non-Hispanic

  - 26% Hispanic9% Two or More Races
  - 2% Black/African American, Asian, or American Indian or Alaska Native
- ~ 30% of FRL students
- ~ 12% receiving special education services (not including students with 504 plans)
- ~ 13% mobility rate (as of EOY SY20-21)

- MSCS has received a "Performance" rating for the State Performance Framework ("SPF") every year since its second year of operations.
- The School consistently outperforms the Colorado Springs 11 school district (the "District") in English language arts and science.
- Math improvement strategy:
  - A middle school math teacher was hired in the 2019-20 school year to provide consistency and expertise in math instruction for grades 5 through 8.
  - The School offered a math camp over the 2021 summer.
- Due to its holistic education, MSCS is recommended by Pediatricians and special needs service providers to students with learning disabilities, skewing its assessment results.
  - Many families opt out of state CMAS testing, some of which have high performing students.
  - The Authorizer understands the Waldorf model does not "teach to a test" and board members have indicated they appreciate MSCS' innovative nature.
